ARAC Resolution 2023/01

The General Assembly approved the Agenda of the 11th GA meeting, Rev 02

ARAC Resolution 2023/02

The General Assembly confirmed the minutes of the 10th General Assembly meeting held on 08th December 2022, as presented.

ARAC Resolution 2023/03:

The General Assembly welcomes the following decisions endorsed by the ARAC MLA Group regarding the ARAC MLA Signatory status of the Saudi Accreditation Center [SAAC]:

- 1. Continues as ARAC MLA Signatory for the accreditation scopes listed below:*
 - Accreditation of Inspection Bodies (ISO/IEC 17020)*
 - Accreditation of Calibration Laboratories (ISO/IEC 17025)*
 - Accreditation of Testing Laboratories (ISO/IEC 17025)*
- 2. Becomes ARAC MLA Signatory for the accreditation scope listed below:*
 - Accreditation of Medical Testing Laboratories (ISO 15189)*
 - Accreditation of Management Systems Certification Bodies (MS) (ISO/IEC 17021-1)*
 - o Quality Management Systems QMS (ISO 9001)*

*The next evaluation of SAAC shall be conducted no later than **April 2027**.*

ARAC Resolution 2023/04:

The General Assembly welcomes the following decisions endorsed by the ARAC MLA Group regarding the ARAC MLA Signatory status of the Egyptian Accreditation Council [EGAC]:

Based on the review of the self-declaration provided by EGAC, the ARAC MLA Group approves the extension of the ARAC MLA signatory status of EGAC to include the following levels 4 & 5 sub-scopes:

- ISO/IEC 27006 Information technology -- Security techniques -- Requirements for bodies providing audit and certification of information security management systems (Level 4),*

- *ISO/IEC 27001 - Information technology - Security techniques - Information security management systems – Requirements (Level 5).*
- *ISO 13485 - Medical devices – Quality management systems – Requirements for regulatory purposes (Level 5).*

*These sub-scopes shall be evaluated at the next ARAC Re-evaluation of EGAC scheduled no later than **January 2026**.*

ARAC Resolution 2023/05:

The General Assembly welcomes the following decisions endorsed by the ARAC MLA Group regarding the ARAC MLA Signatory status of the Jordanian Accreditation System [JAS-AU]:

Continues as ARAC MLA Signatory for the accreditation scopes listed below:

- *Accreditation of Testing Laboratories (ISO/IEC 17025)*
- *Accreditation of Medical Testing Laboratories (ISO 15189)*
- *Accreditation of Calibration Laboratories (ISO/IEC 17025)*

*And decided that the next full ARAC MLA re-evaluation of JAS-AU takes place no later than **October 2026***

ARAC Resolution 2023/06:

The General Assembly agrees to extend the ARAC MLA to include the accreditation of validation and verification bodies according to the international standard ISO/IEC 17029.

The General Assembly requests the Technical Committee and the MLA Group to follow the requirements and procedures of the PR 025 item 04 to extend the arrangement.

The ARAC Secretary will update structure of the MLA defined in the procedure PR 025 according to this approved extension.

ARAC Resolution 2023/07:

The General Assembly, acting on the recommendation of the Technical Committee, resolved to withdraw the ARAC procedure ARAC PR 012: Interlaboratory Comparison Procedure, issue 01, issued in March 2013.

ILAC-R6:11/2023 – Structure of the ILAC Mutual Recognition Arrangement and Procedure for Expansion of the Scope of the ILAC Arrangement.
